## INSTRUCTIONS FOR USE FIBALON POLYESTER FILTERING AGENT

Distributor and manufacturer: Dari GmbH (Egerländer Strasse 1, D-92318 Neumarkt/OPF)

## Conditions of use with respect to public health considerations:

- 1) The product may only be used within the field of bathing water supply.
- 2) The temperature of water coming into contact with the product must not exceed 60 °C.
- 3) For the purpose of water treatment and disinfection, as well as water distribution solely those chemicals, technological equipment items and structural materials coming into direct contact with drinking water may be used which satisfy the stipulations set forth in Annex No. 5 of Government Decree 201/2001 (25 October) (i.e.: registration by the Office of the Chief Medical Officer, license on drinking water safety MSZ EN and MSZ EN ISO standards), and as regards to biocidal products the stipulations set forth in joint Decree 38/2003 (07 July) ESzCsM-FVM-KvVM of the Minister of Health, Social and Family Affairs, the Minister of Agriculture, and the Minister of Environment Protection and Water Management.
